FORMATS

LECTURES

Two-hour long framing lectures given by an internationally renowned scholar. These sessions will focus on transversal challenges facing early stage scholars seeking to delineate their epistemological framework. To this end, three sets of overarching conceptual challenges will be touched upon: (1) those associated with constructing and evaluating a conceptual framework; (2) those born from operationalizing and measuring a given concept; and (3) the pitfalls to avoid when building typologies and ideal types. All three of these conceptual challenges are shared by all Social Scientist and should therefore feed all of the attending ESRs' work. Each session will include a presentation by the guest speaker followed by a Q&A session.

PANEL DISCUSSIONS

The program foresees a single panel discussion set up with an eye on concluding the workshop's first more lecture driven stage. The three scholars having lead the introductory framing session will be invited to jointly revisit the opportunities and limits of typologies. Each panel member will be invited to share their point of view on the topic with an eye on interacting with the other members of the panel. Questions from the attending audience will provide for further input. Overall, the shared question is how typologies can best serve the various constituent research projects of the GEM-STONES project

ROUND-TABLES

Three roundtables are included in the program. Chaired by a member of the GEM-STONES community, these sessions seek to further the implementation of one of the program's specific agenda points. A first round-table will further the coordination and follow-up of the GEM-STONES textbook; a second one will contribute towards the program's skills training agenda; whereas the final round-table will ensure further progress is made with regards to the GEM-STONEs joint data-set.

Each round-table will see a short framing presentation by the chair followed by an open discussion with all attending parties, most notably the 15 GEM-STONES ESRs. The goal of its session is to take stock of the progress made with regards to each of the three agenda points, and agreed on the schedule moving forward.

CONCEPT SESSIONS

The program foresees five so-called concept sessions. Each of these will broach between 6 and 10 key concepts shared by most Social Sciences. The 30 something concepts thus identified are to be discussed by all attending scholars with an eye on reaching an agreed upon understanding, possibly even a workable definition which bridges both the disciplinary as well as conceptual divides that crisscross throughout the GEM-STONES research project.

Each session will see one or two lead academics present the concept from their specific perspective. This is to be followed by a discussion with the attending fellows with an eye on reaching a common understanding.
